Anticipation...

It's hard to believe, but fall is already coming to a close and winter is right around the corner. As we move into November, the anticipation of the Holiday Seasons will be upon us; first Thanksgiving and then Christmas. As the anticipation builds, so, too, does the excitement. Who will come over for Thanksgiving Dinner (or where will we go)? What pies will my mother make this year? I anticipate having my family over for Christmas Eve for appetizers and cookies. And the list goes on. Anticipation is unique in that at times what is being anticipated is known, and, at other times, the anticipation is more about the unknown or what might happen.

The unique nature of anticipation holds true here at ECS.

Looking back, we could not have anticipated that it would rain so hard in a short span of time that the water would actually backflow through the windows on the lower level of the Elementary School. Fortunately, in general, schools anticipate needing emergency funds at some point in time, and therefore have established reserves, fund balances, etc. We know we will have to remove / repair the flooring throughout the lower level of the Elementary as well as some sections of dry-wall. Moving forward the Board of Education will have to explore ways to address these repairs. While we will receive insurance money, it will not cover the entire costs of what needs to be done. Therefore, the District will most likely have to look at an "emergency capital project." An emergency capital project does not follow the normal route of a traditional capital project; its scope is more limited, voter approval is not needed and the overall cost of such a project is far less than a "bigger" capital project. None the less, the costs are higher than average for typical repairs. Beyond the repairs, the flooding in the Elementary School has created quite a disturbance to the day-to-day operations for the students that have classes in this area. All 5 classrooms, the CSE office and the OT/PT program had to be relocated throughout the school. Some classes moved to the libraries, one to the home and careers room, and Mrs. Tomblin's class found itself on the



stage. While the teachers and students anxiously anticipated returning to their rooms, they are to all be commended on their flexibility and understanding during this time. As the year progresses, I will keep you abreast of how we are moving forward with repairs in the lower level of the elementary.

On a different note, for the past few years, ECS has eagerly anticipated the 3-8 testing results each summer. This year we received a pleasant surprise from Buffalo's Business First. When the results were released, they looked at the 4th grade ELA and Math results in 451 upstate school districts, regardless of the size of the school, and ranked the top 50 schools for each exam. Based on the percentage of students that received a "4" on these exams, Ellicottville made both top 50 lists! ECS was ranked 43 for ELA and 3 for Math! I feel it is safe to say that the entire staff and community at ECS anticipate continued success in the classrooms.

As the Holidays approach, I anticipate that the students, staff and community will rise to the spirit of the season, as this has

been a long standing tradition here at ECS. Perhaps the biggest show of generosity is through Project Christmas. I am always amazed at how the entire school community comes together to support those that are less fortunate throughout the season.

And, while I never want to assume, I feel confident in saying that I anticipate many other positive and exciting things taking place. I anticipate the student athletes will continue to put academics first and demonstrate sportsmanship. I anticipate successful holiday concerts as the students have been diligently practicing in band and chorus. I anticipate that families will enjoy the "Family Fun Night" in December, and I'm sure the younger students are eagerly anticipating seeing Santa that evening. In short, I will continue to anticipate great things for ECS and its students!

Idling Buses on School Grounds

State law requires school districts to take steps to minimize the idling of the engines of school buses and other school vehicles on school grounds. While students are boarding and departing school buses, the engine should be turned off. Students should be instructed about the importance of getting on and off buses in an orderly and efficient fashion to minimize loading and offloading time. Bus engines should also be off while parked at sporting events and other school activities. Exceptions to this "no idling" policy can be made in cases of emergency, mechanical issues or for necessary heating.

Safety Drills

LOCKDOWN/LOCKOUT/ AND SHELTER IN PLACE DRILLS

By regulation and in addition to fire drills, we must conduct four (4) lockdown drills each year. Please be advised that prior to December 21st we will conduct two (2) such drills. For the first lockdown drill we will send out an automated call to let you know about it in advance. Please feel free to discuss the drill with your child / children, and reinforce that they need to take the drill seriously, remain calm during the drill and follow staff instructions. For the remaining lockdown drills, we will not be making announcements to parents in advance, as we truly need to ensure that students and staff are ready and able to go into a lockdown drill quickly and with as little instruction as possible to best ensure everyone's safety.

In an effort to communicate to everyone involved that we are running a drill, we will clearly use the word "drill" when making the announcement to begin. For example, the announcement may say "At this time we would like everyone to enter into a lockdown drill." Or, we may decide to start out with a shelter in place or lockout drill and then move into a lockdown drill; in which case the announcement may say "At this time we would like everyone to enter into a shelter in place drill," which would then be followed in a few minutes by "we would now like everyone to enter into a lockdown drill."

We will be talking to students about the importance of not using their cell phones to call or text anyone when we conduct such drills, as that could lead to unnecessary confusion. We would also like to point out that in event of a true lockdown situation, students are not to call or text anyone, as that could compromise their safety, as well as their classmates' safety.

Changes For a Safer School...Part 1



This article is the first of a series that will be in the newsletters this year. The purpose of these articles will be to notify you of important changes that we will be making in order to better ensure student safety. Some of these changes may not be convenient, but we must always keep in mind that student safety outweighs convenience.

The biggest change that we will be making will take effect on Monday, November 26th, and will have the greatest effect on the elementary school. Currently, we allow parents dropping children off in the morning the ability to come into the school. Once in the school, some parents simply wait with their children until the bell sounds for students to go to class. At times parents will visit with one another. Still, others will proceed to their child's room to

talk to the teacher. While there is nothing inherently wrong with these activities, they do, indeed, compromise safety.

In light of this, we are going to make the following changes:

- Parents will drop their child/ children off just outside the elementary doors in the morning.
- Parents wishing to discuss a concern or their child's progress with a teacher will have to either make an appointment with the teacher or have the office see if the teacher is available.
- Parents entering the building will have to report directly to the elementary office.
- Middle and high school students will have to enter the building via the high school entrance.

These changes should drastically cut down on the congestion in the elementary foyer in the mornings.

Another change that will take effect on Monday, November 26th, will pertain to middle and high school students. These students will now be required to enter the building via the high school entrance.

We would like to remind parents and students that the "normal" time for students to unload from the busses in the morning is 8:00 except if the student will be eating breakfast. Students will be permitted to get off the bus when it arrives at the school if they are going directly to the cafeteria for breakfast. Students in grades Pre-K – 6 arriving before 8:00 and wishing to eat breakfast will be dropped off at the elementary entrance. Middle and high school students arriving before 8:00 and wishing to eat breakfast will be dropped off at the high school entrance. These students are to pick up their breakfasts and proceed directly to the cafeteria (except seniors). In both cases, students are to remain in the cafeteria until 8:00 and will not be permitted to go to lockers, roam the halls, go to the locker rooms, etc.

While these changes may seem small, we truly feel that they will make a difference in better ensuring student safety. There will be less congestion in certain areas, visitors to the school will be accounted for, and having students report directly to the cafeteria ensures proper supervision.

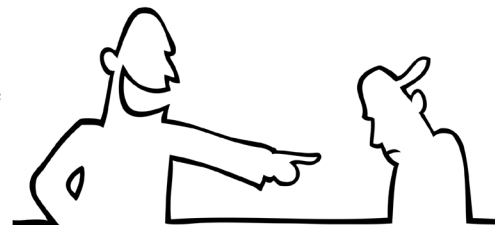
Homeless Student Policy

All programs and services of the district are available to homeless students and unaccompanied youth. Whenever a homeless child or unaccompanied youth seeks to enroll in the district, and at least twice annually, while the child is enrolled, the parent and child will be informed of their rights. Some of these rights include the right to attend the school they previously attended or to attend school in the district of current location, the right to be enrolled even though the admission requirements

have not been completed and prior student records are not available, and the right to transportation to and from school.

ECS EAGLES SPORTS REPORT



Passing the Baton

Mr. Karl Schwartz proudly served the student athletes of ECS for the past 12 years as the Athletic Director. Appointed to the position on January 1, 2007, Mr. Schwartz worked tirelessly year in and year out to ensure that the athletic programs at Ellicottville thrived. During his time as AD, he attended meetings all over WNY, cheered the Eagles on at athletic events across New York State, helped coordinate banquets, worked to combine sports teams with at least 5 neighboring school districts, and had 3 teams bring home State Championships! After many years of success as the AD, Mr. Schwartz stepped down from the position on October 20, 2018 in order to concentrate more on teaching science, Biology and Chemistry (due to the ever changing NYS standards), and to spend more time with his family. ECS is truly appreciative for the leadership Karl provided to the athletic department.

The AD torch will be passed on to Mr. Chad Bartoszek, who is obviously no stranger to the strong tradition of student athletes at ECS. Hired in August of 2013 as a physical education teacher, he also became the Varsity Football and Girls Basketball Coach that school year. Over the past 5 years, Mr. Bartoszek coached the Football team to 4 sectional finals (winning in 2015) and the Girls Basketball team to the Section 6 finals in 2016. Coach Bartoszek also served as the Varsity Club advisor since joining ECS. We are excited that Mr. Bartoszek has been appointed to the AD position, know that interscholastic sports are in good hands, and the tradition of excellence will continue at ECS.

Interscholastic Athletics Notes...

• Earlier this fall the Athletic Committee and Sports Boosters held a joint meeting to discuss potential changes to the end of season sports banquets. After careful consideration, this group decided on some changes to help keep costs to the Sports Boosters reasonable while providing meaningful end of season programs to students.

These changes are:

- 🏆 For the majority of sports, we will be moving away from sit down meals to receptions that will have an assortment of desserts and possibly a few light appetizers. These receptions will be held a little later in the evening to allow families to eat a meal at home. The format for these receptions will be recognizing the athletes and handing out awards first, followed by the serving of desserts and/or appetizers. The Sports Boosters will provide the desserts/ appetizers for these receptions.
- 🏆 For the fall and winter seasons, only JV and Varsity players will attend these receptions.
- 🏆 Football will hold a different reception/banquet due to the manner in which the program is equally split between two schools. The ECS Sports Boosters will provide an assortment of desserts and possibly a few light appetizers. There will also be a meal with this banquet where anyone in attendance, including student athletes, will have to pay for their meal.
- 🏆 For the spring / end of the year awards banquet, again, only JV and Varsity players will attend this event. The exact location, menu and cost to attend this banquet still needs to be determined, but it will include a meal.
- 🏆 Modified teams will have end of the year activities separate from the above receptions and banquets. These activities will be organized individually by the coaches of each of the sports.

• The Sports Boosters are looking for help from parents / volunteers from all levels of sports. They can use help with concession stands, volunteering at events such as the half marathons, event parking, etc. Please remember that Sports Boosters exists for all student athletes at ECS. The fact is, the majority of opportunities for Sports Boosters to earn money takes place in the fall via events such as fall fest and the lacrosse tournament. The Sports Boosters also needs help with the concession stand throughout the Basketball season. Please keep this in mind if you are asked to volunteer; while your daughter / son may not be playing in a sport in a particular season, they are benefiting in the end via events such as the end of season receptions, banners in the gym, equipment purchases, etc. We would also like to stress that parent / adult volunteers are needed. It is not really fair for parents to simply send younger students to help without attending and helping themselves. In these scenarios the adults that attend also end up assuming responsibility for the younger student athletes that are unaccompanied by an adult.

• This year the Sports Boosters would like to recruit a parent liaison for each team. This parent would be the primary contact between the Sports Booster organization and the varsity coach of a given sport. If you are interested in being a team liaison, please contact Todd Palmatier or your child's coach.

• When an ECS team makes the playoffs it is an exciting time. While we would like to hold pep-assemblies for all playoff competitions, we cannot logistically do this. As a general rule, ECS will hold pep assemblies as follows:

- 🏆 6–12 Pep Assembly for Sectional Finals
- 🏆 Send off for Final Four (walk the halls)
- 🏆 State Championship – Parade through the school if the team returns victorious!

Girls' Varsity Soccer



Regular season action began on Aug. 31 with a 3-2 loss against Fredonia. The next contest was versus Olean in the first round of the Olean Tournament on September 5. The Lady Eagles were outplayed by a skillful and fast squad, losing the match 8-1. In the consolation game of the tournament Portville outscored our squad 3-2 in an exciting overtime game. Parents' Bill of Rights for Data Privacy and Security

The Ellicottville Central School District is committed to ensuring student privacy in accordance with local, state and federal regulations and district policies. To this end and pursuant to U.S. Department of Education (DOE) regulations (Education Law §2-d), the district is providing the following Parents' Bill of Rights for Data Privacy and Security:

- A student's personally identifiable information cannot be sold or released for any commercial or marketing purposes.
- Parents have the right to inspect and review the complete contents of their child's education record, including any student data maintained by the Ellicottville Central School District. This right of inspection of records is consistent with the federal Family Educational Rights and Privacy Act (FERPA). Under the more recently adopted regulations (Education Law §2-d), the rights of inspection are extended to include data, meaning parents have the right to inspect or receive copies of any data in their child's educational record. The New York State Education Department (SED) will develop further policies and procedures related to these rights in the future.
- State and federal laws protect the confidentiality of personally identifiable information and safeguards associated with industry standards and best practices, including but not limited to, encryption, firewalls and password protection, must be in place when data is stored or transferred.

Parents have the right to have complaints about possible breaches of student data addressed. Complaints should be directed to: Ellicottville Central School, ATTN: Mr. Robert Miller, Superintendent, 5873 Route 219, Ellicottville, New York 14731.

- Complaints to SED should be directed to: Chief Privacy Officer, New York State Education Department, 89 Washington Avenue, Albany, NY 12234; the e-mail address is cpo@mail.nysed.gov. SED's complaint process is under development and will be established through regulations from the department's chief privacy officer, who has yet to be appointed.
