BOCES Administrative Budget Vote & Board Member Election (April 18, 2017).

Steve Crowley – CA BOCES Board Member introduced himself to the Ellicottville Central Board Members. He stated that one of the goals of the CA BOCES Board Members is to go to the component districts they represent and attend a few board meetings during the year. He told the board members and administration if they have any concerns or questions to please contact him and he would relay any concerns to Lynda Quick, District Superintendent. He stated that the BOCES Annual Meeting will be held tomorrow (Tuesday, April 5th) at the Olean BOCES Center and dinner will be provided. He added that many great things are happening at BOCES regarding the students and their programs. He stated that he enjoys being on the Board and it is very rewarding. Superintendent Ward stated that in his time there has never been a BOCES Board Member that came to visit a local school district board meeting and thanked Mr. Crowley for attending the meeting.

Superintendent's Report (Mark J. Ward):

- 1. Continuing to work on Smart Schools Grant. Have already spent \$200,000 on touch screens and have about \$143,000 left. In the process of putting in a surveillance system in the school. Had a meeting today to place cameras in hallways and video conferencing system in offices. Bob Miller has done quite a bit of work with the company (UNS Services) out of Tonawanda (they have an office in Olean). There are two techs for the company that live in the Franklinville area.
- 2. New program Continuing Leader in Teacher Education. Tracking new teachers who hold a professional certificate. They have to log 100 hours of professional development every five years.
- 3. April 20th Superintendent's Association (Catt/Allegany Counties) will hold a "Call to Leadership" panel discussion and dinner. Superintendents in 22 districts will each recommend a few people who may have the desire to go down the leadership road.
- 4. Plus One Pathways New avenues of obtaining a diploma.
- 5. Budget later in the meeting the Board will be asked to approve the Budget to be put before voters on May 16, 2017. The Board and administration have worked for months creating a sound budget. The Board will ask voters to go above the tax cap. Superintendent Ward stated that the district does not want to use any more reserves. The vote will require the Super Majority vote of 60% to go over the cap.
- 6. Key Highlights of the 2017/2018 Budget
 - •More computers (around 70)
 - •Curriculum (money put in budget new superintendent can decide which direction to go)
 - •New college courses through Syracuse University (Spanish and Geology)

•2 new lease buses (separate proposition) will bring total to 11. Next year will have to lease 2 small and 2 large.

•Reduce BOCES Tech Staff member (replaced with Joe Schultz). Joe is doing an excellent job.

- •Dropping Distance Learning will save the district around \$40,000
- •Buildings and Grounds will build new concrete steps (lower elementary entrance)

-Remodeling of 3 classrooms in the elementary will free up space to rent 3 additional rooms to Big Picture Program. They will have their own principal and secretary next year and use a separate entrance.
•Science Kits – will be joining BOCES

- •Looking into new phone system this summer (IPA for 3 years). Internet based phone system.
- •If anyone has questions about the budget or STAR Program newsletters (especially April) have valuable articles in them.
