Informational Items:

Capital Project Update – Superintendent Ward stated that Board Members have been provided with a Construction Project Estimates Report and would like them to review it. Carl Calarco stated that he would like the board members to pay particular attention to Section II, which deals with Proposed and Accepted aspects of the project. Superintendent Ward stated that the committee met today and went through the project items and looked at what can and cannot be included. The estimate was that the project as submitted is around \$943,000 over budget. He stated that the committee looked at the core values of the project and what the voters approved. President Spell asked board members to take a look at the list and send Superintendent Ward an email with their thoughts.

Superintendent’s Report

1. Board Members were sent a 1st draft of the 2014/2015 school year calendar.
2. Race to the Top money (\$17,490) will be used for last summer’s curriculum work.
3. Presentation scheduled for tomorrow night (January 15, 2014) with Dr. Nickerson from the University of Buffalo. Ms. Nickerson will be the keynote speaker at the event, which will deal with Bullying. All 7th & 8th Grade students and parents are invited to attend. The event is limited to 7th & 8th grade as specific activities are planned in break-out groups and it may not be as effective if the groups get too large. The target area right now is 7th & 8th grade but the program may be expanded in the future for 5th & 6th graders. Superintendent Ward stated that we cannot have kids treating others in such ways. He stated that a teacher suggested handing out the poem “Children Learn What They Live”. Each family will be given a copy of the poem at the end of the evening.
