Informational Items:

- a. 2017/2018 School Calendar 186 day draft calendar presented to board members for their review. Superintendent Ward stated that there are a couple of emergency days built into the calendar. He stated that teachers and staff are paid for 184 days in their contracts. Superintendent Ward asked board members to review the calendar and let him know if they have any questions or concerns. He stated that the approval of the calendar would be on the next board meeting agenda.
- **b.** BOCES Annual Meeting (April 5, 2017)

Superintendent's Report (Mark J. Ward):

- **a.** Continuing to fine-tune the budget. Aimee will walk the board through the budget a bit later in the meeting. The board will vote on the budget at the April 4, 2017 meeting.
- **b.** Letters have been mailed to Assemblyman Giglio and Senator Young explaining Ellicottville's lack of funding. In the last few years the district has used \$1M in reserves to improve facilities and balance the budget. In the letter a comparison was presented of Ellicottville tax rates and neighboring district's tax rates.
- c. Closing in pretty soon on NYS Budget.

d. April newsletter has been sent to print. Work will begin on the May issue which has the budget insert. Part IV of the budget series will focus on taxes, STAR and Enhanced STAR. STAR equates to \$253.80 per taxpayer in the Ellicottville District (if the taxpayer applies for the STAR exemption).

- Going over the Tax Cap would require a Super Majority, which equates to 60% voter approval on the budget. ECS cannot continue to live off of the reserves.
- Superintendent's Day held on March 17th. Very productive day. A lot of good programs and software training (teachers training teachers. Bob updated the teachers on the shortened APPR form and also NYSPHSAA Bulling presentation. Jeff Weiss from Harris Beach gave an excellent presentation to all staff members regarding "Social Media."

Principals Reports:

Elementary Principal/CSE-CPSE Chairperson (Connie Poulin):

- a. First day of testing went smoothly. Very few opt outs in the elementary. 19 students in grades 3-8 did not take the tests. Mrs. Poulin stated that the tests were fair but very challenging.

Superintendent Ward stated that the committee felt it is a good budget and keeps the district in the direction it has been going over the last several years. He stated that there is money in the budget for an additional elementary teacher if needed and a new phone system. He added that the Tax Cap decision needs to be made at the board meeting next Tuesday, April 4th in order to have time to prepare all budget items (newsletter, report card, etc.).
