In surveying 33 schools, he said all felt the split breaks are not good. ECS board members and administrators stated that they agree Mr. Schwartz, but it may be too late to change for the 2016/2017 school year. They stated that he should ask the teacher's union to write a letter to Lynda Quick, the BOCES Superintendent, and explain the advantages of going back to a two week break. They added that in order to possibly get all districts to change for the 2017/2018 school year, they need to start working on it right now.
