Presentations & Reports

Aimee Kilby (District Treasurer) – Mrs. Kilby reported on her attendance at the NYS School Business Management Workshop November 4-6 in Albany, New York. She stated that the workshop was quite helpful and provided information pertaining to the Affordable Care Act, Reserve Accounts, Capital Project Implementation (After the Vote – getting the project built and financed), Extra Classrooms, Smart School Bond Act, Treasurer Responsibilities, Transportation Aid, Records Retention and ST-3 Supplemental Schedules 10-16. Mrs. Kilby thanked the board and administration for giving her the opportunity to attend the workshops.

Communications, Commendations

- a. Capital Project Update Superintendent Ward stated that he and President Calarco discussed having the board's Buildings & Grounds Committee meet with SEI and Campus in the next few weeks and also have a walk through of the building. Superintendent Ward discussed the importance of the Building Condition Survey and how it will set the tone for future capital projects. He stated that main areas to be addressed in a future project will be the bus garage, cafeteria and hs wing roof. Superintendent Ward stated that temporary lockers have been installed for the students and the six foot lockers should be in around the end of January. He stated that the cost of the six foot lockers will be split three ways between SLR, SEI and Campus. The tile and flooring have been installed in the back hall and the benches have arrived. The chairs have arrived (both sets, the black and the maroon). The clock for the hall display is in working order. Mark Mongillo stated that he would like to be on site when the clock is installed (hopefully next week) to make sure nothing goes wrong. The new cover for the front of the state will most likely be ordered through Toth. Not sure yet about the panel for across the bleachers. The proposal submitted does not seem practical (a 100 foot span clipped in front of the bleachers). Still having lighting issues. Locker room drains and showers have been fixed.
- **b. APPR Negotiations** The preliminary plan has been finalized and a waiver has been filed and received. Superintendent Ward stated that he placed a small article in the October/November 2015 district newsletter explaining the situation to residents.

- b. Dave Pelton has requested permission to bid on a wheel chair van. Superintendent Ward stated that the van has 99,000 miles on it and is a 2010. He stated that brand new it would cost around \$75,000. Jim Wiley asked if Mr. Pelton was going to go to Ohio and look at the van. Superintendent Ward will ask Mr. Pelton to take a drive down and look the van over. The board agreed to give Mr. Pelton the authority to forge ahead with bidding on the van (if after viewing the van he feels it is still a good deal).
- c. All School Photograph Patty Watson photographer of the "Tree for Troops" which was done three years ago has approached the district and asked to do a snowman picture at Holiday Valley. Superintendent Ward stated that the administration has decided not to take Mrs. Watson up on the offer. He stated that it may be a good idea to do a photograph again in a few years, but it is a lot of work and he would like to defer it. He stated that Mrs. Watson did a photo shoot of Holiday Valley and their employees for free and in return Holiday Valley would purchase the shirts for the ECS photo shoot. He stated that perhaps in the future the picture could be taken on ECS property. He added that he is not against the project, but it is a lot of work and there are many logistical problems.
