Presentations & Reports

Matt Finn and Dave McCann attended the board meeting to present the 8th grade class trip to Washington, D.C. Mr. McCann and Mr. Finn stated that the trips tentative dates are June 21-23, 2014. The cost of the trip for 2 nights and 3 days is \$498. Mr. Finn stated that they thought about asking West Valley Central School if they would like to combine trips and tag along. West Valley currently has 12 students in its 8th grade class. Mr. Finn stated that if they have more students go on the trip the cost could drop by \$63 per student. The company that they would like to use for the trip is Explorica, Inc. There will be 1 chaperone for every 10 students. Superintendent Ward stated that he thought it was a good idea to reach out to West Valley Central School and see if they would like to go along on the trip. The Board will formally approve the trip at the November 18, 2014 Board Meeting.

Communications, Commendations

a. Letter sent to West Valley Central School Board of Education Members – Carl Calarco stated that a letter was sent to West Valley Central School Board Members on behalf of the Ellicottville Central School Board of Education simply stating that the Board is open to conversations regarding the sharing of services, sports, and educational services. President Calarco stated that no response has been received, to date, adding that the letters were just sent out at the end of last week.

- a. Capital Project The demolition phase of the project has been completed and the pouring of concrete began on Monday. The steel should arrive around December 8th.
- b. Strategic Planning A meeting will be held on Thursday, November 20th at 7:00 pm in the HS Cafeteria. Superintendent Ward stated that is has been five years since the last plan was approved (2009). He stated that it is time to update the plan. Connie Poulin will once again facilitate the meetings. Committees will be set up and will establish their own times to meet. The committee as a whole will then meet and combine ideas and update the plan. The goal is to update the plan and have the Board approve it the Spring of 2015. Superintendent Ward asked board members to encourage community members to get involved.
- c. NYSSBA Conference Michelle Cortez stated that the conference was a great experience. She stated that it was very helpful to meet with fellow board members from other districts. She stated that informative sessions were held on assessments, shared services and data. She concluded by stating the conference was an overall great learning experience.

Superintendent's Report

- a. ECS will be hosting Ellen Sirianni Frank on November 12th at 7:00 pm in the High School Library. Mrs. Frank will share her father's (Dan Sirianni former ECS Superintendent) experiences through WWII. Mr. Sirianni was shot down in the war and held for almost two years in a POW camp. 63 years later (2006) he returned to Germany.
- b. Project Christmas The Great Valley Fire Department donated \$3,500 to Project Christmas. The project services families in the community as well as senior citizens. The efforts for senior citizens will be doubled this year. Senior Citizens in nursing homes will receive poinsettias.

Discussion Items

a. Small Capital Project – Superintendent Ward stated that the Board is considering a small capital project to be put before district residents in January 2015. He stated that because the bids came in high on the current capital project a few key items can not be completed. He stated that the new entrances were a key component of the project for safety reasons. He stated that the past winter did a number on the roofs. Roofing needs to be replaced on a majority of the building. The elementary roof has not been replaced since it was installed in 1988. Superintendent Ward stated that because the district stayed under the NYS Tax Cap, the cost of the current project this year, was paid for by New York State, as residents who are STAR eligible received a rebate check for the difference paid in 2013/14 school taxes and 2014/15 school taxes. Superintendent Ward stated that the small project being considered will be under \$1,000,000. More information will be available at the November 18th board meeting. The district is currently working with its financial advisors and architects to come up with more concrete numbers.
