### Superintendent's Report (Mark J. Ward):

- **a.** Enrollment opening numbers are at 651 students. Highest since 2003.
- **b.** Musical for grades 6-8 will be in November and a play will be in October for HS students. Jon Wilder is spearheading the play. Will need 3-4 more advisors for the MS musical.
- c. APPR had a phone conference with Albany today. Plan to submit the final plan tomorrow am.
- d. Working on Professional Development Plan. Will need input from teachers. The plan will focus on data driven decisions which will include core curriculum aligned with the standards, continuing to promote "No Bullying", Technology (Schoology & Interactive Screens which will help with instruction and communication. All teachers and administrators have to log 100 hours over a 5 year period (who have an initial or professional certificate). Permanent Certificate holders need to register, but do not need to log the hours.
